

ORDINANCE NUMBER 05-2014

AN ORDINANCE TO AMEND THE WATER/SEWER RATES AND FEES FOR RESIDENTIAL AND COMMERCIAL ACCOUNTS.

BE IT ORDERED AND ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF RIDGELAND, SOUTH CAROLINA IN COUNCIL ASSEMBLED AND BY THE AUTHORITY THEREOF THAT THE WATER/SEWER RATES AND FEES FOR RESIDENTIAL AND COMMERCIAL ACCOUNTS FOR THE TOWN OF RIDGELAND IS AMENDED TO READ:

Water and Sewer System

0-2,000 Gallons	Minimum	\$19.55	\$29.38
2,001-10,000	Per Thousand	\$ 3.10	\$ 3.75
10,001- & Above	Per Thousand	\$ 3.25	\$ 3.75

Sewer:

Residential		In-Town	Out-Town
0,2,000 Gallons	Minimum	\$17.83	\$25.88
2,001-10,000	Per Thousand	\$ 3.85	\$ 5.75
10,001- & Above	Per Thousand	\$ 3.85	\$ 5.75

Commercial		In-Town	Out-Town
0- 2,000 Gallons	Minimum	\$28.75	\$36.80
2,001- 10,000	Per Thousand	\$ 4.25	\$ 5.25
10,001 & Above	Per Thousand	\$ 4.50	\$5.25

Irrigation Rates:

Base Fee \$2.70 (Minimum Charge \$2.70)

0- and above gallons \$2.70 Per Thousand

Wholesale Water and Sewer Rates: Will be determined by the Town Council as negotiated on a case by case basis.

Deposits:

1. Residential: \$100.00
2. All Others: An amount equal to two (2) months of the estimated monthly bill as determined by the SCDHEC Contributory Loading Schedule.

Cut-Off Fees: \$30.00

Returned Check Fees:\$30.00
