

# REQUEST FOR QUALIFICATIONS (RFQ) FOR ENGINEERING SERVICES FOR REGIONAL WATER AND SEWER MASTER PLANNING PROJECT TOWN OF RIDGELAND, SC

**December 23, 2022** 

#### A. OVERVIEW AND PUBLIC NOTICE

The Town of Ridgeland, South Carolina (the "Town") requests Statements of Qualification and Rate Schedules from qualified, South Carolina licensed engineering companies with demonstrated experienced in regional water and sewer master planning. The Town desires to develop a 20-yr (2022-2042) water and sewer master plan (the "Master Plan") using a regional approach to determine the most efficient and cost-effective manner to improve the reliability and performance of the Town's existing water and sewer infrastructure and to identify the water and sewer system improvements and strategies needed to serve the growth projected to occur in the Town and adjacent areas of Jasper County over the planning period.

The intent of this RFQ is to select an experienced engineering company to complete the Master Plan. The selected Consultant must be capable of performing the following tasks and delivering the following on behalf of the Town:

This will include the following:

# Task 1 - Existing Conditions and Data Gathering

- Delineate study area
- Review existing water and sewer GIS maps
- Assess current water and sewer populations and determine Per Capita Use

#### Task 2 – Current State Assessment

- Condition assessment of existing water and sewer facilities to include Probability and Consequence of Failure Scores
- Identification of existing private well and septic users
- Inflow and Infiltration Assessment

#### Task 3 – Future Conditions –

- Evaluate projected land use and development trends to identify growth areas and allowed densities and delineate underserved water & sewer areas
- Evaluate 20-yr population growth projections and identify the areas where the growth will occur. Determine the future water and sewer demands associated with the projected growth.
- Assessment of the available capacity of the existing water and sewer infrastructure and identify areas where the geology and development density will support continued use of septic systems.

Task 4 – Hydraulic Modeling of water and sewer systems & Future Service Options

- Review the existing water and sewer models (SewerGEMs platform developed by Bentley & WaterGEMs platform developed by Bentley) and update if needed.
- Incorporate the projected 20-yr future water and sewer demands in the model to determine the options available to provide water and sewer services
- Identify areas within the current and future Town limits that could be better served by existing and planned Beaufort Jasper Water and Sewer Authority (BJWSA) infrastructure.

#### Task 5 – Master Plan Implementation

- Develop a Water & Sewer Rehabilitation Capital Improvement Plan to include a project description and Engineer's Opinion of Probable Cost and Risk Prioritization
- Develop a Water & Sewer Expansion Capital Improvement Plan to include a project description and Engineer's Opinion of Probable Cost.
- Develop a list of areas best served BJWSA and provide the framework and strategies needed to develop a long-term water and sewer services agreement. This work must include exploring the feasibility of formal partnerships between the Town of Ridgeland and Beaufort Jasper Water and Sewer Authority ("BJWSA") and documenting the evaluation of partnerships and potential consolidation agreements with BJWSA.

# Task 6 – Funding Evaluation

• Develop strategies to fund the Capital Improvement Plans developed in Task 5.

**Deliverables** – The deliverables for the study will be the Master Plan report that will include an Executive Summary and a detailed description of the work associated with each Task shown above.

Schedule – The Town anticipates issuing a notice to proceed by March 1, 2022. This effort will be partially funded by a Rural Infrastructure Authority (RIA) Grant and the project <u>must</u> be completed within the grant period, which ends on October 31, 2022.

**Section B** outlines the items to be included in the Statement of Qualifications and any limits or formats such information should be provided in. Along with the Statement of Qualifications, the vendor will complete Appendix A, RATE SCHEDULE. After reviewing all submittals, the Town may then elect to interview firms.

Requirements for the Statement of Qualifications and Appendix A are outlined in Section B Submittal Requirements. All submittals must provide the information requested or will not be considered. One original, one copy and one .pdf file of the Vendor's submittals must be delivered to the Town Administrator:

No later than January 31, 2022 at 12:00 noon (EST.) Submittals received after this time and date will not be accepted or opened for review by the Town.

Subject to the terms, conditions, provisions, and the enclosed specifications, responses to this solicitation will be received at this office until the stated date and time. After which, only the names of the respondents will be publicly announced. Responses received after the scheduled due date and time will be rejected. **Proposals must be submitted in a sealed package marked on the outside with the Offeror's name, address, and the solicitation name and number.** This solicitation does not commit the Town to award a contract, to pay any costs incurred in the preparation of proposals submitted, or to procure or contract for the services. The Town reserves the right to accept or reject or cancel in part, or in its entirety offers received as a result of this request if deemed to be in the best interest of the Town to do so.

# **B. SUBMITTAL REQUIREMENTS**

**Overview:** The Town is seeking to contract with a qualified engineering firm to conduct the Master Plan.

The Town of Ridgeland owns, operates and maintains a water system and a sewer system consisting of the following:

One Water System with all components interconnected:

- three (3) well sites with disinfection
- five (5) active elevated storage tanks
- approximately 43 miles of watermains ranging in size from 2-inch to 8-inch

One Sewer System with all components interconnected:

- 1.6 MGD Jimmy Mixson Water Reclamation Facility (WRF)
- 16 pump stations
- approximately 15 miles of forcemains ranging in size from 2-inch to 8-inch
- approximately 450 manholes
- approximately 21 miles of gravity sewer mains, which vary in size from 6-inch to 12-inch

The water system serves a roughly 6.7 square-mile area within the Town of Ridgeland limits and the Cypress Ridge Industrial Park and Ridgeland Claude Dean Airport which are both owned by Jasper County. The sewer system serves a 5.6 square-mile area within the Town of Ridgeland limits and the Cypress Ridge Industrial Park and Ridgeland Claude Dean Airport. Accordingly, only 14% of the Town's 48.3 square-mile limits has water service and only 12% has sewer service. Exhibit 1 (Attachment C) depicts the Town's water and sewer systems service areas, the Jasper County limits in the vicinity of the Town, and the Beaufort-Jasper Water and Sewer Authority (BJWSA) service areas

As listed previously, the Town owns and operates a water utility, wastewater utility in the Town as well as some unincorporated areas just outside the Town limits. It is anticipated that the engineering services requested by the Town will be in these major services areas as well as with GIS support services.

**Items to be Included in Submittal:** All submittals must provide the information requested, in the order provided below and be limited to the quantity of information where noted:

- 1. Cover and Cover Letter One page cover and no more than a two-page cover letter. The Consultant may provide whatever information it believes is pertinent in its cover letter. The Consultant should acknowledge their receipt of any Addendum that may have been issued it it's cover letter.
- 2. **Information About the Firm** Provide information about the Firm:
  - a. Home office location and physical regional office locations (maximum one page)
  - b. **Key Principals and Managers** and their location (Consultant may provide a regional organizational chart)
  - c. Brief history of the firm (no more than three pages)
  - d. Organization Chart showing the proposed Project Team. Provide a brief (no more than one page) resume on each key staff member.
- 3. **Experience** The Vendor should provide descriptions of projects of similar scope.

The Vendor may provide up to three examples of projects that reflect their expertise and experience in Master Planning.

- 4. **References:** Provide three key references that can attest to the firm's ability to perform the work. Attachment "B" is provided and should be completed for each reference.
- **5. Project Approach:** Provide a description of how the Consultant plans to complete the Master Plan
- **6. Rate Schedule** Attachment "A" is the form that must be used to provide the Rate Schedule. As not all titles are interchangeable from firm to firm, the description of each staff type is provided as generically as possible. If necessary, the Vendor can provide up to a one page clarification.

#### C: INSTRUCTIONS TO VENDOR

1. Submittal must include:

- a. Two hardcopies of the Vendor's proposal responses (one clearly marked as "original" and the other clearly marked as "copy") and one .pdf electronic file copy clearly marked accordingly and in compliance with Section "B" above.
- b. A completed W-9 form.
- c. A current Certificate of Insurance (See Section 21of this RFQ)
- d. Completed Attachment "A" Rate Schedule
- e. Completed Attachment "B" References
- f. Responses must be in a sealed envelope/package containing the solicitation name and number. The individual signing the response must be an Agent legally authorized to bind the company. Show solicitation number on the outside of mailing package. The Town assumes no responsibility for unmarked or improperly marked envelopes.
- 2. It is the vendors sole responsibility to ensure that solicitation responses, amendments thereto or withdrawal requests are submitted by the scheduled due date and time.
- 3. The vendor must clearly mark as "Confidential" each part of their response, which they consider to be proprietary information that could be exempt from disclosure under Section 30-40(C) Code of Laws of South Carolina, 1976, Freedom of Information Act. The Town reserves the right to determine whether this information should be exempt from disclosure and legal action may not be brought against the Town or its agents for its determination in this regard.
- 4. All responses shall be printed in ink or typewritten. Proposals written in pencil will be disqualified.
- 5. This solicitation does not commit the Town to award a contract, to pay any costs incurred in the preparation of RFP submitted, or to procure or contract for the services. The Town reserves the right to accept or reject or cancel in part, or in its entirety offers received as a result of this request if deemed to be in the best interest of the Town to do so.

All responses to questions will be addressed and answers to questions or requests for clarifications will be provided by Addendum that will be clearly posted on the Town's Website.

#### **D: SELECTION CRITERIA:**

### **Evaluation Criteria and Responsive Proposer Selection**

A selection committee will evaluate proposals based solely upon the 6 evaluation criteria listed in this Section. The selection committee reserves the right to request additional information from any or all proposers during the time that proposals are being evaluated. Also, during the evaluation of the received proposals, at the selection committee's option, a shortlist may be developed, and respondents may be interviewed before a firm is selected. Upon the selection committee's completion of evaluations, it will make a recommendation to the Town with respect to the selection of a proposer. Please revise the wording of Section D to reflect that the proposals will be evaluated only on the listed evaluation criteria.

All information provided in this RFQ document should be reviewed with the criteria to be evaluated in this proposal as follows:

The following criteria and scoring will be considered when evaluating the qualifications and experience of the Consultant's who have submitted submittals. This list is in general and not specific nor limited to these items:

- 30% Experience and qualifications of proposed staff
- 30% Past performance on similar type projects
- 20% Project Approach
- 10% Availability of proposed staff
- 5% Familiarity with the local area
- 5% Rate Schedule

#### E: SPECIFIC TERMS AND CONDITIONS

**1. COMPETITION**: This solicitation is intended to promote full and open competition. If any language, specifications, terms and conditions, or any combination thereof restricts or limits the requirements in this solicitation to a single source, it shall be the responsibility of the interested vendor to notify the Town Administrator in writing no later than five (5) business days prior to the scheduled due date and time.

- **2. RESPONDANTS QUALIFICATION**: The Town reserves the right to request satisfactory evidence of their ability to furnish services in accordance with the terms and conditions listed herein. The Town further reserves the right to make the final determination as to the Vendor's ability to provide said services.
- **3. RESPONSE WITHDRAWAL**: Any responses may be withdrawn prior to the established closing date and time, but not thereafter with proper approval from the Town Administrator.
- **4. REJECTION**: The Town reserves the right to reject any and all proposals, to cancel or withdraw this solicitation, and to waive any technicality of any type if deemed to be in the best interest of the Town
- **5.** WAIVER: The Town reserves the right to waive any Instruction to Offerors, General or Special Provisions, General or Special Conditions, or specifications deviation if deemed to be in the best interest of the Town.
- 6. RESPONSE PERIOD: All responses shall be good for a minimum period of 90 calendar days.
- **7. DEVIATIONS FROM SPECIFICATIONS**: Any deviation from specifications indicated herein must be clearly pointed out; otherwise, it will be considered that items offered are in strict compliance with these specifications, and successful offeror will be held responsible therefore. Deviations must be explained in detail on separate attached sheet(s). The listing of deviations, if any, is required but will not be construed as waiving any requirements of the specifications. Unidentified deviations found during the evaluation of the response may be cause for rejection.
- **8. AMENDMENTS**: All amendments to and interpretations of this solicitation shall be in writing and issued by the Town Administrator and issued by Addendum.
- **9. DEBARMENT**: By submitting a qualification package, the Firm is certifying that they are not currently debarred from responding to any request for proposals by any agency or subdivision of the State of South Carolina or the United States Federal Government, nor are they an agent of any person or entity that is currently debarred from submitting proposals on contracts by any agency or subdivision of the State of South Carolina.
- **10. DEFAULT**: In case of default by the Firm, the Town reserves the right to purchase any or all items in default in the open market, charging the Firm with any excessive costs. Should such charge be assessed, no subsequent solicitation response of the defaulting Firm will be considered in future RFP's until the assessed charge has been satisfied.
- 11. HOLD HARMLESS: All respondents to this RFP shall indemnify and hold harmless Town of Ridgeland officers and employees and elected officials from all suits and claims alleged to be a result of this request for proposals. The issuance of this request of proposals constitutes only an invitation to present a proposal. The Town reserves the right to determine, at its sole discretion,

whether any aspect of a respondent's submittal meets the criteria in this request for proposals. The Town also reserves the right to seek clarifications, to negotiate with any Firm submitting a response, to reject any or all responses with cause, and to modify the procurement process and schedule. The negotiations will occur based on the ranking order resulting from the evaluation of responses.

- 12. CANCELLATION: In the event that this request for proposals is withdrawn or the project canceled for any reason, the Town shall have no liability to any respondent for any costs or expenses incurred in connection with this request for proposals or otherwise.
- **13. FAILURE TO SUBMIT ALL MANDATORY FORMS**: Failure to submit all the mandatory forms from this request of proposals shall be just cause for the rejection of the qualification package. However, the Town reserves the right to decide, on a case by case basis, in its sole discretion, whether or not to reject such a proposal as non-responsive.

#### **14. CONTRACT AWARD:**

This solicitation and submitted documents, when properly accepted by the Town shall constitute an agreement equally binding between the successful Firm and the Town. No oral statement of any person shall modify or otherwise change, or affect the terms, conditions or specifications stated in the resulting agreement. The Town shall not be legally bound by any amendment or interpretation that is not fully executed by both parties in writing.

The successful Firm shall be required to execute a formal agreement with the Town's Administrator within ten (10) business days after issuance of the Notice of Award.

**15**. **CONTRACT ADMINISTRATION**: Questions or problems arising after award of an agreement shall be directed to the Town Administrator by calling (843) 726-7500. Copies of all correspondence concerning this solicitation or resulting agreement shall be sent to The Town of Ridgeland, Attn. Town Administrator, One Town Square, PO Box 1119, Ridgeland, SC 29936.

#### F: ADDITIONAL CONTRACTUAL REQUIREMENTS

- 1. ABANDONMENT OR DELAY: If the work to be done under this contract shall be abandoned or delayed by the Firm, or if at any time the Town shall be of the opinion and shall so certify in writing that work has been abandoned or delayed by the Firm, the Town may annul the contract or any part thereof if the Firm fails to resolve the matter within thirty (30) days of written notice.
- **2. FIRM'S COOPERATION**: The Firm shall maintain regular communications with the Project Manager and shall actively cooperate in all matters pertaining to this contract.
- **3. RESPONSIBILITY**: The Firm shall at all times observe and comply with all federal, state, and municipal laws, ordinances, rules and regulations in any manner affecting the contract.

- **4. NON-APPROPRIATION** / **SUBSTITUTION PERMITTED**: If the Ridgeland Town Council fails to appropriate or authorize the expenditure of sufficient funds to provide the continuation of this contract or if a lawful order issued in, or for any fiscal year during the term of the agreement, reduces the funds appropriated or authorized in such amounts as to preclude making the payments set out therein, the agreement shall terminate on the date said funds are no longer available without any termination charges or other liability incurring to Town. Following any such non-appropriation, the master lease agreement shall contain no limitation on the Town's ability to replace the equipment financed with any other equipment.
- 5. INDEMNIFICATION: Except for expenses or liabilities arising from the negligence of the Town, the Firm hereby expressly agrees to indemnify and hold the Town harmless against any and all expenses and liabilities arising out of the performance or default of any resulting agreement or arising from or related to the Work as follows: Firm expressly agrees to the extent that there is a causal relationship between its negligence, action or inaction, or the negligence, action or inaction of any of its employees or any person, firm, or corporation directly or indirectly employed by the Firm, and any damage, liability, injury, loss or expense (whether in connection with bodily injury or death or property damage or loss) that is suffered by the Town and its employees or by any member of the public, to indemnify and save the Town and its employees harmless against any and all liabilities, penalties, demands, claims, lawsuits, losses, damages, costs, and expenses arising out of the performance or default of any resulting agreement or arising from or related to the equipment. Such costs are to include defense, settlement and reasonable attorneys' fees incurred by the Town and its employees. This promise to indemnify shall include bodily injuries or death occurring to Firm's employees and any person, directly or indirectly employed by Firm (including without limitation any employee of any subFirm), the Town's employees, the employees of any other independent Firm, or occurring to any member of the public. When the Town submits notice, Offeror shall promptly defend any aforementioned action. The prescribed limits of insurance set forth herein shall not limit the extent of the Firm's responsibility under this Section. The terms and conditions contained in this Section shall survive the termination of any resulting agreement or the suspension of the Work hereunder. Additionally, the Town will not provide indemnity to the successful FIRM. Failure to comply with this section may result in your request for proposal to be deemed non-responsive.
- **6. FORCE MAJEURE**: The Offeror shall not be liable for any excess costs if the failure to perform the resulting agreement arises out of causes beyond the control and without fault or negligence of the Firm. Such causes may include, but are not restricted to acts of God or of the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, and unusually severe weather; but in every case the failure to perform must be beyond the control and without the fault or negligence of the Firm. If the failure to perform is caused by default of a sub-consultant, and if such default arises out of causes beyond the control of both the Firm and sub-consultant and without excess costs for failure to perform, unless the supplies or services to be furnished by the

sub-consultant were obtainable from other sources in sufficient time to permit the Firm to meet the required delivery schedule.

- 7. CONDUCT OF FIRM: The Engineering Firm's (Firm) personnel must exercise a particularly high level of discipline, safety and cooperation at all times while on the job site. The Firm will be responsible for controlling employee conduct, for assuring that its employees are not boisterous or rude, and assuring that they are not engaging in any destruction or criminal activity. All Town, Town and local codes, rules and regulations concerning safety will be strictly adhered to by the Firm. The Firm will be responsible for assuring the safety of his employees, Town employees, and the general public during performance of all services under this contract. Possession and consumption of drugs or alcoholic beverages is strictly prohibited at all times at the job site and on or around the Town's property and will be considered a breach of contract. Work may be temporarily stopped by the Town Administrator or his designee due to severe weather, lack of material, safety violations or other unforeseen circumstances.
- **8. BUSINESS LICENSE:** The Firm must obtain a Town business license.
- **9. ARBITRATION**: Under no circumstances and with no exception will the Town act as arbitrator between the Firm and any sub-consultant.
- 10. PUBLICITY RELEASES: Offeror agrees not to refer to award of this contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the Town. The Firm shall not have the right to include the Town's name in its published list of customers without prior approval of the Town Administrator. With regard to news releases, only the name of the Town, type and duration of any resulting agreement may be used and then only with prior approval of the Town. The Firm also agrees not to publish, or cite in any form, any comments or quotes from the Town's staff unless it is a direct quote from the Procurement Manager.
- 11. GOVERNING LAWS: Any agreement arising from this solicitation shall be governed by the laws of the State of South Carolina and any and all disputes arising out of said agreement shall, if litigation is necessary, be litigated only in a Circuit Court for the Fourteenth Judicial Circuit sitting in Ridgeland, South Carolina. The prevailing party shall be entitled to attorney's fees and all costs of said litigation.
- **12. ASSIGNMENT**: The Firm shall not assign in whole or in part any agreement resulting from this Request for Proposals without the prior written consent of the Town. The Firm shall not assign any money due or to become due to him under said agreement without the prior written consent of the Town.
- 13. AFFIRMATIVE ACTION: The successful Firm will take affirmative action in complying with all Federal and State requirements concerning fair employment and treatment of all

employees, without regard or discrimination by reason of race, color, religion, sex, national origin or physical handicap.

**14. FAILURE TO DELIVER SERVICES IN ACCORDANCE WITH TERMS & CONDITIONS**: In case of failure to deliver services in accordance with the contract terms and conditions, the Town, after due oral or written notice, may procure substitute goods or services from other sources and hold the Firm responsible for any resulting additional purchasing and administrative costs. This remedy shall be in addition to any other remedies which Colleton Town may have.

#### 15. TERMINATION OF CONTRACT:

- 1. Subject to the Provisions below, the contract may be terminated by the Purchasing Department providing a thirty (30) days advance notice in writing is given to the Firm.
  - a. Termination for Convenience: In the event that this contract is terminated or canceled upon request and for the convenience of the Town without the required thirty (30) days advance written notice, then the Town shall negotiate reasonable termination costs, if applicable.
  - b. Termination for Cause: Termination by the Town for cause, default or negligence on the part of the Firm shall be excluded from the foregoing provisions; termination costs, if any, shall not apply. The thirty (30) days advanced notice requirement is waived and the default provision in this request for proposals shall apply.
  - c. The Town shall be obligated to reimburse the Firm only for those services rendered prior to the date of notice of termination, less any liquidation damages that may be assessed for nonperformance.
- 2. Non-Appropriations Clause: Not withstanding any other provisions of the contract, if the funds anticipated for the continued fulfillment of this contract are at any time. Not forthcoming, through the failure of the Town Government to appropriate funds, discontinuance or material alteration of the program under which funds were provided, the Town shall have the right to terminate the contract without penalty by giving not less than thirty (30) days written notice documenting the lack of funding. Unless otherwise agreed to by the Town and the Firm, the contract shall become null and void on the last day of the fiscal year for which appropriations were received.
- **16. GOVERNING LAWS**: Any contract resulting from this request for proposals shall be governed in all respects by the laws of the State of South Carolina and any litigation with respect thereto shall be brought in the courts of the State of South Carolina.
- 17. BONDS: Payment and Performance Bonds are not required for this RFQ.

- **18. OWNERSHIP OF MATERIAL**: Ownership of all data, material, drawings, specifications and any other project related documentation originated and prepared for the Town pursuant to this contract shall belong exclusively to the Town.
- **19. TYPE OF CONTRACT:** The contract will be negotiated with the selected firm for the specific deliverables listed (the Master Plan).
- **20. INSURANCE**: The Town will require the following remain in force at all times through the life of the contract:
  - Professional Liability Insurance Minimum \$1,000,000.00 Proof of in force insurance must be provided in the response to the RFP.
  - Workers' Compensation \$100,000 each accident Statutory Coverage and Employer's \$100,000 each employee Liability \$500,000 policy limit
  - Comprehensive General Liability -\$1,000,000 bodily injury each occurrence \$1,000,000 bodily injury aggregate \$1,000,000 property damage each occurrence \$1,000,000 property damage aggregate Products -
  - Completed Operations \$1,000,000 aggregate
  - Business Auto Liability Same as Comprehensive General Liability
  - Excess or Umbrella Liability \$1,000,000 Colleton

A copy of the Vendor's Certificate of Insurance should be included as part of its response to this RFQ. Town will be named as an "additional insured" should the Vendor be selected to perform the work.
