REQUEST FOR BIDS

Sealed Bids for the construction of the Expansion of the Jimmy Mixson WRF will be received by the Town of Ridgeland at the Ridgeland Town Hall until 2:00 PM EST on Tuesday, May 14, 2019 at which time the bids received will be publicly opened and read.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

The project consists of upgrades: Purchase, construction and installation of new influent pump station with forcemain, headworks facility, sequencing batch reactors (1.6 MGD), effluent pump station, effluent filters, UV disinfection, digester, dewatering facilities (Geotube dewatering bags), removal of sludge from existing lagoons, new operator building.

Bidding Documents are available on compact disc (as portable document format (PDF files) for a non-refundable charge of \$50 payable to Goldie Associates, including shipping via overnight express service. Alternatively, printed Bidding Documents may be obtained from the Issuing Office in person pick-up or mail, upon issuing office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$250 per set, payable to Goldie Associates plus a non-refundable shipping charge. Upon issuing office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the issuing office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda if any, obtained from sources other than the issuing office.

A mandatory pre-bid conference is scheduled for Tuesday, April 16, 2019 at 2:00 PM EST, meeting at Ridgeland Town Hall, One Town Square, Ridgeland, SC 29936.

Bid security shall be furnished in accordance with the Instructions to Bidders.

The owner reserves the right to waive any irregularities or to reject any or all bids.

No bidder may withdraw his bid within **sixty (60) days** after the actual date of the opening thereof.
