

04-2020 ORDINANCE NUMBER

AN ORDINANCE TO AMEND THE WATER/SEWER RATES AND FEES FOR RESIDENTIAL, COMMERCIAL AND IRRIGATION ACCOUNTS.

BE IT ORDERED AND ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF RIDGELAND, SOUTH CAROLINA IN COUNCIL ASSEMBLED AND BY THE AUTHORITY THEREOF THAT THE WATER/SEWER RATES AND FEES FOR RESIDENTIAL AND COMMERCIAL ACCOUNTS FOR THE TOWN OF RIDGELAND IS AMENDED TO READ:

Rates will be effective for July 1, 2020 Billing Cycle.




